# Playground

Through the very hard work and advocay of Kim Street and Trustee Tuchansky Joan Carr will get a Playground in 2023. For background the Neighbourhood Park Development Program was suspended – City of Edmonton money; Without this grant it would likely have taken 5-7 years for the playground.

There is a piece of land that ECSD owns at Joan Carr and that will be used as the playground site. The tender for playground designs has gone out and designs will come back on March 13<sup>th</sup>. There will not be much that can be changed in these designs as the tender had to be put out in order to have a playground for the fall. The tender was based on the survey to the community as well as the designs made by Joan Carr Students in Grade 4 and Grade 7. Colors can be changed.

A meeting may be required to present and approve the playground design. Tenders will be vetted by ECSD purchasing. Once selected it will take 8-10 weeks for the equipment to get her and construction is slated to begin at the end of June. It will take 10 days to put the equipment in. Rubber will be put in as the playground base and its installation will be weather dependent.
